The candidates who have applied and qualified the CET – 2022 examination (for Group-C Posts) by obtaining 38 or more marks and who are resident/domicile of Haryana were required to verify/withdraw their claim made against socio economic criteria vide Public Notice dated 01.02.2023. After uploading the said notice various candidates approached the Commission that if they get verified their Govt. job status in family and family income status now through concerned authorities, then the concerned authorities would issue fresh certificate and same would be after cut-off date i.e. 10.07.2022. Therefore, the Commission has decided that the candidates who intend to verify their claim regarding family income and status of Govt. job in their family need not get certificate issued from concerned authorities and such candidates can submit/upload their undertaking after self-attesting the same to the effect that the annual family income for the (FY2021-22, FY 2022-23) was less than one lakh eighty thousand rupees only and neither the candidate himself nor any person amongst the applicant's family as mentioned in the advertisement is/was or has been a regular employee in any Department/ Board/ Corporation/ Company/ Statutory Body/Commission/ Authority of Haryana Government or any other State Government or Government of India till 10.07.2022.

Note 1: The candidates are relaxed from provision of verification of “No family member in government job status” and “family income status” from concerned authorities for their convenience only. However, if at any stage during or after process of CET and subsequent recruitment it is found that self-undertaking to the above points of family income and Government Job status in family are wrong then the candidature of such candidate will be rejected, recommendation if made shall be withdrawn and if appointed then his/her Services shall be terminated on this ground even if without these marks such candidate is still in merit of the selected candidates. **Note 2: Format for self-attested undertaking is appended below with this public notice. Candidates are required to upload undertaking in the format provided for the purpose, undertaking in any other form/manner shall not be accepted.**

following information for claiming weightage under the Socio-Economic-Criteria namely : -

1. That I have applied for the CET 2022 for Group 'C' in HSSC against Advt. 01/2022.
2. That my PPP No _____ Aadhaar/ Pan Card/ Voter Id No. _____.
3. **That I have read and understood the provision of Socio-Economic-Criteria under which I am entitled for the marks as under:**
 "An applicant who is bonafide resident of Haryana shall be entitled to 5% weightage provided that—
 - (i) **neither he himself nor any person from amongst the applicant's family is/was or has been a regular employee in any Department/ Board/ Corporation/ Company/ Statutory Body/ Commission/ Authority of Haryana Government or any other State Government or Government of India(on or before 10.07.2022); and**
 - (ii) **Gross annual income of the family from all sources i.e., salary, agriculture, business, profession etc. for the financial year prior to the year of application should be less than one lakh eighty thousand rupees only (FY2021-22, FY 2022-23)."**
4. The definition of Family for the purpose of Socio-Economic Criteria—
 - (i) male applicant means the applicant himself, his father, mother, wife, unmarried brother(s) and son(s);
 - (ii) female unmarried applicant means the applicant herself, her father, mother and unmarried brother(s);
 - (iii) female married applicant means the applicant herself, her husband, father-in-law, mother-in-law, unmarried brother-in-law and son(s);
 - (iv) divorced female applicant means the applicant herself, her father, mother, unmarried brother(s) and son(s);
5. That any person among in my family in Government Job having separate PPP No/family ID/ Ration Card will not be entitled to be awarded weightage under Socio-Economic Criteria having no Government Job.
6. **If a person himself or his family member is once selected/appointed with or without getting the benefit of weightage, no other family member shall be considered for weightage for selection/appointment to the same or any other post for which application has been submitted by any member of the family.**
7. That no person as mentioned above had been in employment and gross income of family is less than One lakh Eighty thousand Rupees only, I may be allotted weightage under the socio-economic criteria for having no Government Job.
8. That I fully understand that the marks are given on the basis of information supplied by me and if at any stage it is found that the information has been provided wrongly then not only my candidature can be cancelled and if appointed my service can be terminated on the ground of supply of wrong information even if without these marks or weightage also my name would have figured within the select list / recommendation list. I also understand that criminal action can be taken against me for providing wrong/false information.
9. That the deponent shall not take advantage of the certificate(s) issued by the Competent Authority if in meantime any other eligible person in my family obtains the benefits thereof in the recruitment.
